Consider Resolution for the Provision of Additional Local Leave to Employees due to the Expiration of Families First Coronavirus Act

Mr. Terry Marak explained that the Families First Coronavirus Response Act (FFCRA) was passed by the federal government in March 2020 and expired on December 31, 2020. One provision of the act provided employees an additional ten days leave that could be utilized when the employee had to be quarantined due to COVID-19 or needed to care for an individual due to COVID-19. The ESC Region 12 management requests that the Board extend the additional ten days leave through August 31, 2021 pursuant to the FFCRA.
