### Discuss and Consider Approval of Fund Balance Designations and Reservations

### Review and Discuss Annual Performance Report

### Discuss and Consider Approval of Two GEAR UP Student Summer Trips to New York and Boston, not to Exceed \$425,000

The ESC Region 12's GEAR UP grants are planning student trips to New York and Boston for the upcoming summer. Both GEAR UP grants will have students participating and the cost of the trips will be in excess of \$250,000. The center will obtain quotes from the various board approved purchasing cooperatives that ESC Region 12 is a member of and has used for other purchasing needs in the past. Based on this information, the ESC Region 12 management requests the Board approve the ESC 12 staff using one of the Board approved purchasing cooperatives to purchase an allinclusive New York/Boston student trip package not to exceed \$425,000. The Board unanimously approved the request as stated.

### Discuss and Consider Approval of an End of Year Upward Bound Student Summer Trip to New York not to Exceed \$120,000

ESC Region 12's Upward Bound grants are planning student trips to New York for the upcoming summer. All three Upward Bound grants will have students participating and the cost of the trips will be in excess of \$50,000. The center will obtain quotes from the various board approved purchasing cooperatives that ESC Region 12 is a member of and has used for other purchasing needs in the past. Based on this information, the ESC Region 12 management requests the Board approve the ESC 12 staff using one of the board approved purchasing cooperatives to purchase an all-inclusive New York student trip package no to exceed \$120,000. The Board unanimously approved the request as stated.

# Discuss and Consider Approval of RFP for Comprehensive College and Career Readiness Service (e.g. SAT prep, application assistance, STAAR boot camps, etc.)

Education Service Center Region 12 issued an RFP for Comprehensive College and Career Readiness Services. The Center received seven responses and would like to select multiple vendors to provide materials and services. Education Service Center Region 12 management requests that MasteryPrep, LLC and Cambridge Educational Services be approved as vendors. The Board unanimously approved the request as stated.

## Discuss and Consider Approval of Upward Bound Residential Stay Not to Exceed \$75,000

Education Service Center Region 12's Upward Bound grant issued an RFP for a summer residential stay for grant students. Region 12 is in the process of contacting Universities to ask them to respond to the RFP. The RFP has been extended through January 2024 and will not exceed \$75,000. ESC Region 12 management requests the Board approve an Upward Bound Residential stay not to exceed \$75,000. The Board unanimously approved the request as stated.

# Discuss and Consider Approval to Replace the Partition Doors in Waco ABCD, Bluebonnet, Mockingbird, and Pecan Meeting Rooms in Excess of \$50,000

ESC Region 12 is planning to purchase sliding door partitions for Waco ABCD, Bluebonnet, Mockingbird, and Pecan Meeting rooms because the current partitions are breaking down and parts have become impossible to locate. ESC Region 12 issued an RFP and received one response from TRW (Modern Fold). ESC Region 12 management requests the Board approve the purchase of the sliding door partitions from TRW. The Board unanimously approved the request as stated.

## Discuss and Consider Purchase of New Furniture for Brazos, Bowie, Tech Lab, and Travis Meeting Rooms in Excess of \$50,000

ESC Region 12 is planning to purchase furniture for Brazos, Bowie, Tech Lab, and Travis meeting rooms. The furniture purchased will be similar to what has been purchased for other updated meeting rooms. ESC Region 12 management recommends the Board approve Omnia Partners Cooperative to purchase the furniture. The purchase will be in excess of \$50,000 not to exceed \$150,000. The Board unanimously approved the request as stated.
